### **General Conference Information**

#### Code of Conduct and Medical Forms

UFLC is a professional conference, and all conference participants are expected to abide by the **Code of Conduct**. Every participant must read and sign the **Code of Conduct**. Chapter advisors are required to bring these forms to the conference and keep them in the event of a situation requiring their use.

### Supervision Quota

1 Adult per 12 students

The required <u>chaperone ratio is one registered adult per 12 students</u>. Please ensure that your registration is in accordance with this policy. All advisors will be responsible for monitoring behavior in sessions and at the conference, conducting room checks at curfew and providing supervision in the hotel.

### Security

Des Moines Police Department (DMPD) will be on duty throughout the conference including opening and closing sessions. DMPD will strictly enforce the Code of Conduct and curfew. DMPD will **not** replace the responsibility of each advisor monitoring behavior including conducting room checks at curfew.

#### Curfew

Curfew is 12:00 AM (midnight) to 6:00 AM. No food is allowed to be delivered to any room after 12:00 AM (midnight).

#### **Business and Career Fair**

Exhibits are conveniently located in the Iowa Events Center. Participants can visit the Business and Career Fair Exhibits from 8 AM to 12:10 PM on Monday. Exhibits will range from school store vendors, colleges, and companies interested in recruiting CTSO members.

### Association Delegation Meetings

Association delegation meetings will be held Monday at the Iowa Events Center at 12:15 PM Consult the conference program for the exact time and location of your Association's meeting.

#### **Dress Code**

Business representatives, press, hotel staff and guests will be seeing Iowa CTSO's finest members—show them a professional business image.

#### Sunday - CTSO Casual Attire

Participants may wear CTSO casual attire on Sunday. Jeans or slacks will be permitted with a CTSO t-shirt, conference t-shirt, or CTSO colored shirt.

#### Monday – Business Professional Attire

Dress shirt/blouse and dress skirt/slacks; dress shoes are required. A business suit and CTSO blazer are optional.

The following items are not allowed: denim, athletic shoes, sweatshirts and t-shirts, shorts and hats.

#### **Unacceptable Attire**

The following are unacceptable during <u>any</u> activities: skin-tight or revealing clothing, athletic clothing, midriff-baring clothing, swimwear and clothing with printing that is suggestive, obscene or promotes illegal activities, leggings, sweatpants, shorts or joggers.

### Conference Expectations

To be eligible to attend the United Fall Leadership Conference, the student must have earned the right to attend by demonstrating desire to participate fully in all scheduled conference activities, and a commitment to live by the Code of Conduct while attending. Permission from the local advisor, the school and the student's parent/guardian to attend are also required.

Responsibilities of the advisors for the United Fall Leadership Conference are as follows:

- 1. The advisor will be responsible for all aspects of the trip including travel arrangements, selection and discipline of students, emergency situations, and notification to parents of all aspects of the trip.
- 2. The advisor must provide all students with a written copy of all rules and trip procedures.
- 3. The advisor will be responsible for student supervision, room checks, curfew checks, etc.
- 4. The advisor will be responsible for maintaining a file of all signed agreements from the students and/or parents.
- 5. Monitor curfew at midnight.
- Ensure that there are no food deliveries (both student and advisor) after curfew.

## **Hotel Information**

#### Check-in & Check-out Procedure


